Protection declaration for the pages of Pablo's Skull - Tequila Energy www.pablos-skull.com .

SCOPE

This data protection declaration clarifies users about the type, scope and purposes of the collection and use of personal data by the responsible provider POTUS Vertriebs GmbH, Schulstraße 17, 8111 Gratwein - Straßengel, E-Mail: salud@pablos-skull.com, Internet: www.pablos-skull.com on this website (in the following offer).

The legal basis for data protection can be found in the Federal Data Protection Act (BDSG) and the Telemedia Act (TMG).

ACCESS DATA / SERVER LOG FILES

The provider (or his web space provider) collects data about every access to the offer (so-called server log files). The access data include:

Name of the website accessed, file, date and time of access, browser type and version, the user's operating system, referrer URL (the previously visited page), IP address and the requesting party Provider.

The provider uses the log data only for statistical evaluations for the purpose of operation, security and optimization of the offer. However, the provider reserves the right to check the log data retrospectively if there are reasonable grounds to suspect illegal use.

DEALING WITH PERSONAL DATA

Personal data is information that can be used to identify a person, i.e. information that can be traced back to a person.

This includes the name, email address or phone number. Personal data also includes data about preferences, hobbies, memberships or which websites were viewed by someone.

Personal data is only collected, used and passed on by the provider if this is permitted by law or the users consent to the data collection.

CONTACT

When contacting the provider (for example via the contact form or email), the user's information is saved for the purpose of processing the request and in the event that follow - up questions arise.

INTEGRATION WITH CONTRACTS AND THIRD PARTY TRUST

It may happen that third-party content, such as videos from YouTube, maps from Google Maps, RSS feeds or graphics from other websites, is integrated into this online offer. This always presupposes that the providers of this content (hereinafter referred to as third-party providers) perceive the IP address of the users. Because without the IP address, they could not send the content to the browser of the respective user.

The IP address is therefore required to display this content. We strive to only use content whose respective providers only use the IP address to deliver the content. However, we have no influence on whether the third-party provider uses the IP address e.g. save statistical purposes. As far as we know, we will inform the users about it.

COOKIES

Cookies are small files that make it possible to store specific, device-related information on the user's access device (PC, smartphone, etc.). On the one hand, they serve the user-Friendliness of websites and thus the users (e.g. storage of login data).

On the other hand, they serve to record the statistical data of the website usage and to be able to analyze it in order to improve the offer. Users can influence the use of cookies. Most browsers have an option that limits or completely prevents the storage of cookies.
